ORDER

Honourable Victoria Chiappetta, Chairperson

UPON THE REASONS FOR DECISION of this Tribunal dated January 18, 2021 awarding compensation to the Claimant and directing the Parties to adjust the award by agreement to take account of the adjustment of loss of use from December 31, 2019 to the date of the Reasons for Decision and an adjustment to present value of the current unimproved market value for the period from September 21, 2017 to the date of the Reasons for Decision;

AND UPON THE REQUEST ON CONSENT of the Parties set out in their letter and draft order filed with the Tribunal on April 30, 2021, which indicates they considered the methodology adopted by the Tribunal, equitable compensation principles, that equitable compensation is assessed, not calculated, and that costs are payable to the Claimant;

AND UPON THE RESPONDENT ADVISING that it requires 10 to 15 days from the date of issuance of the Tribunal's Order to complete payment of the compensation to the Claimant;

THE TRIBUNAL ORDERS THAT:

[1] The Respondent shall pay to the Claimant compensation, inclusive of costs, in the sum of \$141,000,000;

[2] The Respondent shall also pay to the Claimant interest in the amount of \$159,349.35 according to subsection 36(2) of the *Specific Claims Tribunal Act*, SC 2008, c 22, which represents interest on \$141,000,000 at a rate of \$10,623.29 per day for fifteen days, from the date of this Order to and including the date of payment;

[3] The total amount payable by the Respondent to the Claimant is \$141,159,349.35; and,

[4] Payment of \$141,159,349.35 shall be made by transfer payment to CIBC Trust Corporation for deposit to the Claimant's Legacy Trust in accordance with the Order to Pay provided to the Respondent by the Claimant and this shall be full and final satisfaction of compensation regarding this Claim.
